General instructions for the Internal Examinations – May, 2021 of Department of Law.

INSTRUCTIONS

- 1. The internal examination will be held through an online mode in a written manner (subjective form).
- 2. Each question paper will contain a total of 4 questions out of which students have to write the answers of 2 questions only.
- 3. There will be a limitation of 100 words per answer. Each answer should not be more than 100 words.
- 4. Timing for the internal examination will be from 08:00 AM in the morning to 06:00 PM in the evening.
- 5. Question papers will be provided in the university group by the Coordinator appointed only 5 minutes before the start of every hour.
- 6. Question paper will be released at 08:00 AM, 09:00AM, 10:00AM, 02:00PM, 03:00PM & 04:00PM sequentially. There will be break from 11:00AM to 02:00PM.
- 7. Students have to write & send all their papers within the provided time only.
- 8. If any student fails to submit his or her answer sheet within the time allotted then he or she will be marked as absent in their Internal Examination May 2021.
- Students have to scan and upload their answer sheets in PDF format only.
 No other formats like photographs or M.S. Words document will be accepted.
- 10. Students have to send their papers to different email ids/whatsapp number provided with their respective subject.

- 11. Each student has to write their Name, Father's Name, Roll No., Subject name, Course & semester and page no. on each page of their answer sheet in the top margin space of the page.
- 12. Use only A4 size white blank paper for writing your answers. Use only blue & black ink pen.
- 13. After opening of the university, the students have to submit the hard copies of the answer sheet to the department.
